By tournament entry, the captain consents that the Bud Light Fishing Rodeo may use without payment or restriction, any photographs in which he/she or any of their crew may appear for any purpose whatsoever; including, but not limited to resale, advertising, commercial or promotional material. The captain and his crew further release the Bud Light Fishing Rodeo, Pensacola Sports, officers and directors, and all persons from injury, loss or damage which may result. All state record winners must submit to and pass in a conclusive manner, a polygraph examination administered by a licensed polygraphist provided by tournament officials. All entrants agree to submit to a polygraph examination at the request of the tournament committee if there is a conflict involving said entrant. Failure to submit to such an examination will result in disqualification of the entrant at the sole discretion of the tournament committee.

I hereby authorize the Pensacola Sports, its agents and assigns and all other media outlets to use and reproduce my name, photograph(s), motion picture, and/or videotape recordings of me or audio recordings of my voice for any and all purposes including promotion and advertising. Herein called "The Rodeo."

I acknowledge that Pensacola Sports will be the sole owner of all rights in and to The Rodeo and the recording thereof, for all purposes.
